## Jewish Home & Rehab Center Charitable Care Policy Plain Language Summary

Jewish Home & Rehab Center provides free or discounted medically necessary care to patients who are either uninsured or underinsured and who qualify for assistance under its Charitable Care Policy. Financial assistance does not apply to elective services.

## Eligibility Requirements and Assistance Offered Under the Charitable Care Policy

Patients who qualify for assistance are eligible for discounts for medically necessary care based on multiple factors including, income, household size, and other available assets. Income eligibility criteria is derived from the Federal Poverty Income Guidelines <a href="https://aspe.hhs.gov/poverty-guidelines">https://aspe.hhs.gov/poverty-guidelines</a>. In general:

- Uninsured patients whose household income is at or below 100% of the Federal Poverty Level are generally eligible for free medically necessary care.
- Uninsured patients whose household income is between 101% and 350% of the Federal Poverty Level generally receive a sliding scale discount ranging from 10% to 90% for medically necessary care.

A patient who qualifies for assistance under the Charitable Care Policy will not be charged more than the maximum amount the Jewish Home & Rehab Center could receive from any government-sponsored health benefit program for the services provided. If a patient applies for charity care and qualifies for a government-sponsored health benefit program, the Jewish Home & Rehab Center will assist the patient with enrollment into the appropriate program.
